## Employer Information

### Chosen fund payment methods

**If your employer is a registered Sunsuper employer** (that is, they already pay contributions to Sunsuper on behalf of other members), they can simply continue using their current payment method for your contributions.

Sunsuper will not keep records of payments made by unregistered employers, you and your employer will be responsible for keeping records of these payments.
