

Terms and Conditions

Sunsuper Pty Ltd Member Seminar Feedback Survey

Entry

1. Sunsuper Pty Ltd (ABN 88 010 720 840) is the promoter ("Promoter") of the Member Seminar Feedback Survey (the "Prize Draw").

6. Incomplete or indecipherable entries will be deemed invalid.

Prize

General

19. The Promoter reserves the right to cancel or amend the Prize Draw or these Terms and Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.

21. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the competition, or suspend or modify a prize.

If this competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the competition, as appropriate.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the competition.
