

**“SUNSUPER RIVERFIRE DREAM PARTY” and “BRISBANE FESTIVAL” 2019
PROMOTION**

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Queensland residents aged 18 years or over who are members of the Sunsuper Superannuation Fund.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. The Grand Prize promotion commences at 12.00am AEST on Thursday 22 August and ends at 11:59pm AEST on Thursday 19 September 2019 (“**Grand Prize Promotional Period**”). The Minor Prize promotion commences at 12.00am AEST on Thursday 22 August and ends at 11:59pm AEST on Sunday 1 September 2019 (“**Minor Prize Promotional Period**”). All times in this promotion are based on QLD local time.
5. To enter the Primary Prize Draw, individuals must, during the Primary Prize Promotional Period:
 - (a) visit the Promoter’s competition website at www.sunsuper.com.au/community/riverfire-dreamparty;
 - (b) follow the instructions on the competition entry page; and
 - (c) submit the fully completed online entry form.
6. To enter the Minor Prize Draw, Entrants must enter the Grand Prize Draw (as outlined in clause 5) during the Minor Prize Promotional Period and click to enter the Minor Prize Draw on the online entry form.
7. Incomplete or indecipherable entries will be deemed invalid.

Registration for online access is available at www.sunsuper.com.au/account/register. Otherwise, only one entry per person is permitted into each of the Grand Prize Draw and the Minor Prize Draw.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

Prize

12. The grand prize pool consists of fifty (50) prizes (each a “**Grand Prize**”) each comprising four (4) tickets to the ‘Sunsuper Riverfire Dream Party’ at *Sunsuper Riverfire 2019* on Saturday 28 September 2019.
13. The minor prize pool consists of thirty-five (35) prizes (each a “**Minor Prize**”) each comprising two (2) tickets to the Brisbane Festival’s ‘Swing on this’ performance at The Spiegeltent on Saturday 7 September 2019.
14. The winners for the Minor Prizes will be drawn at random and the draw will take place at the premises of Sunsuper Pty Ltd at 30 Little Cribb Street, Milton, Queensland 4064 on Monday 2 September 2019 at 10am AEST (“**Minor Prize Draw**”).
15. The winners for the Primary Prize will be drawn at random and the draw will take place at the premises of Sunsuper Pty Ltd at 30 Little Cribb Street, Milton, Queensland 4064 on Friday 20 September at 10am AEST (“**Grand Prize Draw**”).
16. The first 50 valid entries drawn in the Grand Prize Draw will each win a Grand Prize. The first 35 valid entries drawn in the Minor Prize Draw will each win a Minor Prize. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn, or in case any one or more of the winners do not claim their Prize.

18. During the entire duration of the Prize, a nominated parent/guardian must accompany any person under 18 years of age or any person who does not have legal capacity.

General

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
