

Sunsuper My2cents Community

Competition Terms and Conditions

1. Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. Entry is open to residents of Australia aged 18 years or over who receive an invite to participate in the Sunsuper My2cents Community. Directors, managers and employees and their immediate families of the Promoter and its agencies or other companies associated with this promotion are ineligible to enter. "Immediate families" include siblings, parents, children and family living in the same household. Entry in this competition is free of charge; however, any cost associated with accessing the competition website is the entrant's responsibility and is dependent on the Internet service provider used.
3. **To go into the draws for Monthly Rewards (as outlined in Clause 5), entrants must, when invited to do so by the Promoter:**
 - Fully complete an online research survey during the Promotional Period (as defined in Clause 4) and/or contribute to any online My2cents discussion that they have access to during the Promotional Period (as defined in Clause 4).
 - Entrants will receive one entry for each survey completed or any discussion they contributed to.
 - Entrants will go into the Monthly Reward draw for the month that the survey is completed or when they first contributed to a discussion (as shown in clause 6 below). For example, if the survey is completed in November 2018, the entrant will go into the draw in December 2018.
 - Entrants who complete more than one different survey in one month or contribute to more than one different discussion will earn multiple entries into the Monthly Reward draw for that month based on the number of surveys submitted or discussions contributed to (i.e. one entry per survey submitted).
 - Entrants may only complete each survey once. Entrants will only get one entry for multiple contributions to the same discussion.
4. The promotional period commences at 0:00.00 AEST on Tuesday 18/09/2018 and closes at 23:59:59 AEST on Tuesday 17/09/2019 ("Promotional Period").
5. There will be 12 Monthly Reward draws conducted during the Promotional Period which will take place on the next business day after the 15th day of each month, at the premises of the Promoter 30 Little Cribb Street, Milton, Queensland 4064. "Business Day" means a day that is not a Saturday, Sunday or Public Holiday in Brisbane.
6. The first four (4) valid entries drawn for the draws for Monthly Reward will each receive a prize. Prizes for Monthly Rewards consist of four (4) pre-paid gift cards credited to the value of \$100 each for the four (4) winners of each Monthly Reward.

Total RRP value of prizes for all prizes = **\$4800**.

- 8.** In the event that any prize becomes unavailable for reasons beyond the Promoter's control, the Promoter may substitute a prize of equal or greater value, subject to any written directions from the various lottery authorities.
- 9.** Winners will be notified by e-mail within 48 hours of each draw and the names of prize winners will be published at www.sunsuper.com.au/competitions within 7 days of each draw. Winners have one (1) calendar month from the date of draw to claim their prize. Prizes must be claimed by midnight on the relevant date. For example, a prize drawn on 15 October 2018 must be claimed by midnight 15 November 2018. If for any reason a winner does not take a prize (or an element of the prize), by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
- 10.** If necessary, in order to distribute any unclaimed prizes, a second chance draw will be held at the same time and place as the first draw on the first business day following the one (1) calendar month period in which the first draw winner has to claim their prize.
