

Terms and Conditions

Sunsuper Pty Ltd AFA Roadshow 2019 Draw

Entry

1. Sunsuper Pty Ltd (ABN 88 010 720 840) is the promoter ("Promoter") of the AFA Roadshow 2019 Draw (the "Prize Draw").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter, participants must be over the age of 18 and have entered the Prize Draw by entering their business card into the draw.
3. Information on how to enter and the prizes form part of these Terms and Conditions. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("Terms and Conditions").
4. The draw is not open to employees of Sunsuper Pty Ltd (or its associated companies or subsidiaries), or their families.
5. The competition commences at 9.00am AEST 3 June 2019 and ends at 11.30am AEST 6 June 2019 ("Competition Period").
6. Incomplete or indecipherable entries will be deemed invalid.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the competition. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
8. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
9. This is a game of chance and skill plays no part in determining the winner.

Prize

12. Only the Winner shall receive notification from the Promoter. The Winner will be notified either by email, telephone and/or in writing as soon as is practicable after the Winner has been drawn. If the Promoter cannot successfully contact the Winner within 48 hours of the Winner being drawn (making reasonable efforts), then the Winner forfeits the right to the Prize and another entrant will be drawn for the Prize.

13. The decision of the Promoter is final and no correspondence will be entered into.
14. The Prize is non-transferable and there are no cash alternatives. The Promoter reserves the right to substitute the Prize with another of a similar nature and/or equal or greater value at any time. If the Winner is unable or unwilling to accept a Prize, subsequent draws will take place until a new Winner is found who is able/willing to accept the Prize.

Consent and Privacy

16. Participants' personal information as provided on their Business Card will be used to conduct this competition and may be disclosed to service providers and authorities as required. By entering the Prize Draw, the participants consent to being contacted by the Promoter in the future using the contact details supplied on the Business Card used to enter the draw. General

17. The Promoter reserves the right to cancel or amend the Prize Draw or these Terms and Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
18. The Prize Draw, together with these Terms and Conditions, is governed by the laws of Queensland.
19. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the competition, or suspend or modify a prize.
20. If this competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the competition, as appropriate.
21. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the competition.

The Promoter collects personal information ("PI") in order to conduct the competition and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI

as set out in its Privacy Policy, which can be viewed at www.sunsuper.com.au/content/privacy.cfm. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. The Privacy Policy also contains information about how entrants may opt out, access, update or correct their PI, how entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with.
