

Terms and Conditions

Sunsuper Pty Ltd Member Seminar Feedback Survey

Competition October/November 2019

Entry

1. Sunsuper Pty Ltd (ABN 88 010 720 840) is the promoter ("Promoter") of the Member Seminar Feedback Survey Competition (the "Prize Draw").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter, participants must be over the age of 18 and have entered the Prize Draw by completing the relevant survey that was sent to them via email.
3. Information on how to enter and the prizes form part of these Terms and Conditions. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("Terms and Conditions").
4. The Prize Draw is not open to employees of Sunsuper Pty Ltd (or its associated companies or subsidiaries), or their families.
5. The competition commences at 5.00pm AEST on 14th October 2019 and ends at 12.00pm AEST on 21 November 2019 ("Competition Period"). All times in this competition are based on QLD local time.
6. Incomplete or indecipherable entries will be deemed invalid.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the competition. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

Prize

13. The decision of the Promoter is final and no correspondence will be entered into.

The Promoter reserves the right to substitute any Prize with another of a similar nature and/or equal or greater value at any time. Consent and Privacy

General

18. The Promoter reserves the right to cancel or amend the Prize Draw or these Terms and Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
19. The Prize Draw, together with these Terms and Conditions, is governed by the laws of Queensland, New South Wales and Victoria.
20. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the competition, or suspend or modify a prize.

If this competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) to modify, suspend, terminate or cancel the competition, as appropriate.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential,

arising in any way out of the competition.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of/taking/redeeming a prize.

The Promoter collects personal information ("PI") in order to conduct the competition and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
